Gender Pay Gap Report 2018

As Walsall Pressings Company Ltd employs more than 250 people we are required by law to publish an annual gender pay gap report showing the difference in average female earnings compared to average male earnings.

This is our report for the snapshot date of 5 April 2018:

Our Statement

Our median gender pay gap fell from 8.43% in 2017 to 6.24% in 2018. The Annual Survey of Hours and Earnings (ASHE) found the UK's 2018 median pay gap to be 8.6%.

Although all quartiles at Walsall Pressings continues to be skewed towards male employees with long periods of service we have been successful in increasing the percentage of female employees in the upper quartile from 7% in 2017 to 16% in 2018. This change has contributed towards reducing our headline gender pay gap figures.

An analysis of gender pay gap by quartile illustrates the position.

To achieve this the Company will endeavour to maintain a pay system which is transparent, based on objective job assessment/evaluation criteria and free of any irrelevant bias.
